HG&Co works to the Modern Slavery Act, Ethical Trading Initiative (ETI) Base Code, is a member of SEDEX (Supplier Ethical Data Exchange) and Investor In People accredited. We are B Corp and Ecovadis certified, meeting the highest standards of social and environmental performance, and we are committed to reducing the impact of our operations on the environment. We expect our suppliers to embrace and work to our Ethical Trade Policy. This forms part of our consideration and approval of our suppliers. We will give preference to suppliers of environmentally friendly products or services.

As part of our Ethical Trade Policy, we expect our suppliers to comply with the Modern Slavery Act and be continuously improving their compliance with the social and environmental standards as specified below, both in their own organisation and within their supply chains, sub-contractors and service providers. We encourage our suppliers to use third party risk or impact assessment tools e.g. SEDEX, B-Corp. As part of assessing our own environmental impact we may ask for data on your environmental performance. We encourage transparency and sharing of information and would be happy to discuss and share opportunities for improving standards to the benefit of the whole supply chain.

If HG&Co becomes aware of any actions or conditions that violate our Ethical Trade Policy, we will request the supplier to take corrective action. Whilst HG&Co would want to support our suppliers in improvements, if appropriate corrective action is not taken, we reserve the right to terminate any agreements.
